What data do we collect?

Dicentra collects the following data:

- Personal identification information (name, e-mail address, telephone number, organisation, residential address, etc.)

How do we collect your data?

You directly provide Dicentra with the data we collect. We collect data and process data when you:

- Voluntarily complete a consultation survey or provide feedback on any of our message boards or via e-mail.
- Use or view our website via your browser's cookies.

How will we use your data?

Dicentra collects your data for the purposes of any consultation exercise associated with any purpose related to Section 57 (Planning permission required for development) of the Town and Country Planning Act 1990 (as amended) and the Town and Country Planning (Development Management Procedure) (England) Orders 2010 & 2015.

If you agree, Dicentra will share your data with our partner companies so they may also take into account your comments and feedback.

How do we store your data?

Dicentra securely stores your data at Pegasus Group (London Office).

Dicentra will keep your name, e-mail address, telephone number, organisation, residential address, etc. for a period of one year. Once this time period has expired, we will delete your data by removing from our records.

Marketing

We will not use your data for marketing purposes, including from our partner companies.

What are your data protection rights?

Dicentra would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Dicentra for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Dicentra correct any information you believe is inaccurate. You also have the right to request Dicentra to complete information you believe is incomplete.

The right to erasure – You have the right to request that Dicentra erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Dicentra restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Dicentra processing your personal data, under certain conditions.

The right to data portability – You have the right to request that Dicentra transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
